Over the next couple of months, we'll be working with schools and asking parents to take responsibility for their children and get them into something positive.

- Who they are speaking to on the phone?
- Where do they go with their friends?

## Residents invited to have their say in the CPZ consultation

Residents living in Parsloes, Mayesbrook, Whalebone and Heath wards are being urged to get involved in a consultation as their roads are likely to be one where the council is looking to install a Controlled Parking Zone (CPZ) to make it easier for them to park where they live.

- 3. Improve safe access for pedestrians
- 4. Protect parking for residents, visitors and Blue Badge holders

## Borough marks Ugandan Independence Day for the first time

The national colours of the Republic of Uganda were flown outside Barking

Town Hall on Friday 7 October to mark 60-years since the country's independence from the British Empire.

Residents were joined by councillors for the flag-raising ceremony, which took place at 12.30pm, to mark the occasion for the first time in the borough.

The black, yellow and red flag was flown ahead of the official Ugandan Independence Day, which takes place on Sunday 9 October.

The country gained independence from the British Empire in 1962.

## Parents are being reminded to apply for their child's secondary school place

Parents whose children are in Year 6 are being reminded to submit their secondary school application. They have until Monday 31 October to get their applications in to give their child the best chance of being accepted into their first-choice school.

## Help and support available for residents through the Household Support Scheme

Residents who may be struggling with their finances or to make ends meet are being encouraged to get in touch.

Funding is available to vulnerable residents to support them with essentials over the coming months.

Residents can <u>apply online</u> or email <u>benefits@lbbd.gov.uk</u>.

There are also <u>a number of other support services</u> including:

- Our Community Food Clubs which are free of charge and can provide £20 worth of food per week for a period of either three or six months at <u>www.lbbd.gov.uk/community-food-clubs</u>
- Our money and debt webpages provide an income and expenditure calculator and budgeting tools that will help people understand how much money they have coming in and how much is going out, helping them look at areas where they can make savings at <u>www.lbbd.gov.uk/money-and-debt</u>
- Residents who are worried about their finances and need help to tackle debt can now get advice and support from our local Barking and Dagenham Money website at: <u>www.bdmoney.co.uk</u>
- People struggling with increasing energy costs should contact their energy supplier about possible funds they may be entitled to, to help them through difficult periods. They can also access the Warm Homes Grant at <u>www.gov.uk/the-warm-home-discount-scheme</u>
- People with disabilities who aren't claiming specific disability benefits may be able to take advantage of a number of benefits available, including Personal Independence Payments, Disability Living Allowance (for children), and Universal Credit. For those caring for someone with disabilities they may be able to claim Carer's Allowance although this is means tested, at <u>www.gov.uk/financial-help-disabled/disability-andsickness-benefits</u>
- People with a water meter who are experiencing financial difficulties may want to look into the Watersure scheme at <u>www.ofwat.gov.uk/households/customer-assistance</u>. Most water companies also have a fund to help those who are struggling, and it might be worth contacting their water provider.

- People who are out of work and looking to get into employment can get help and support from our Job Shops at <u>www.lbbd.gov.uk/help-finding-</u> work
- Anyone worried about a lack of skills can find courses and support on the Adult College website at <u>https://adultcollege.lbbd.gov.uk/</u>
- Residents who need help with emergency living expenses for food, fuel (gas and electric for customers who pay via a key meter), travel expenses and household appliances and/or clothing in exceptional circumstances can apply for help from our Hardship Fund (Individual Assistance Payment) at <u>www.lbbd.gov.uk/hardship-and-covid-supportschemes.</u>

#### **Opportunity London**

<u>Opportunity London</u>, a major new partnership between London Councils, the City of London and the Mayor of London to promote sustainable investment in real estate, regeneration and green infrastructure across the capital, has had a busy few weeks both at the party conferences and at their own investment summit as part of the London Real Estate Forum (LREF), where the group hosted the Opportunity London Investment Summit.

Regional London partnerships were represented at the summit, as well as panel discussions focused on activating Central London, London's Towns, delivering housing in London, and innovation in London real estate. The group also hosted dinners at both the Labour and Conservative party conferences. In an article published by New London Architecture (NLA), Greg Clark of UK3Ci, sets out the challenges facing London and the city's next development cycle. <u>You can read his article in full here</u>.

#### Cost of living webinar

The London Child Poverty Alliance, with support from London Councils, will host a webinar to help councillors and local authority officials explore ways that they can mitigate the cost-of-living crisis for those on lowest incomes in their communities. The session will look specifically at how Council Tax Reduction Schemes and Local Welfare Assistance programmes can be designed so that they can reach those most in need.

The webinar will be chaired by London Councils Executive Member for Communities (Welfare, Empowerment and Inclusion), Cllr Claire Holland, and speakers will include Child Poverty Action's Head of Policy, Hannah Aldridge, and Director of Policy and Campaigns at Z2K, Marc Francis.

## Finance without numbers – an introduction to local government finance for newly elected members - Monday 31 October, 6 to 7.30pm

This webinar will provide an overview of local government finance without any numbers - focussing instead on roles and responsibilities, key terminology, and processes. It will give you an understanding of both what you need to be aware of in your role and what you need to understand about your authority's role. This webinar, which is funded by Government, is for newly elected members or those just looking for a refresh.

**Youth services – sharing practice among local authorities -** Wednesday 9 November, 3.30 – 5pm

The LGA has explored partnership working in different forms, particularly in exploring the key enablers of effective partnership-based early help and developing an effective youth offer. For youth work week, we want to revisit this research and explore how local authorities and partners are approaching youth service models in their local authorities.

#### **One to One Development Sessions**

The LGA are offering councillors the opportunity to have one-to-one development conversations with one of the Leadership Academy Facilitators. This will be available to councillors in leadership positions for the next three

months. These sessions are not political and will be provided by tutors from the LGA's Leadership Academy programme who a number of councillors might have met from participation on the programmes. They will be focussed on helping councillors adapt their personal leadership style through three structured coaching calls.
