Leader's borough update

In his video this week, the Leader talks about the Levelling Up bid for Dagenham Heathway which saw the borough awarded £10.8m for works to breathe new life into the area. The funding will go towards work to revitalise the Heathway – bringing in 316 new affordable homes, shops and creating new pathway and cycle paths.

He also urges residents to sign up to the Green Garden Waste collection

service and reminds people to get their nominations in for the 2023 Women's Empowerment Awards.



Work underway on new £12m state-of-the-art sports facility at Parsloes Park

Construction of a new community sports centre featuring a gym, fitness studio, a café, and meeting rooms has started at Parsloes Park in Dagenham. The £12 million development will replace the old single-storey pavilion and provide new shower and changing facilities to support 16 grass sports pitches and three 3G pitches.

When complete, one of the pitches will feature four covered seating stands and will become the permanent home for two local football clubs, May & Baker Eastbrook Community FC, who play in the Eastern Counties League Division

One South, and Cobra FC, who feature in The Echo Junior League and the Essex Sunday Corinthian League.

The project is being funded by a £6.2million grant from the Premier League, The FA and the Football Foundation, as well as £6.1million investment from Barking and Dagenham Council with contributions from the London Marathon Charitable Trust and Greater London Authority.

The new sports centre, which is being built by Alliance Leisure, will provide a venue for schools and grassroot sports clubs to hold meetings and education sessions.

Once operational, the Sports Hub will be operated by the charity, Leisure United, under the National Football Trust, itself a registered charity.

All surplus income will be re-invested back into grassroots football in the borough, creating a sustainable future for the sport.



A day of learning for borough landlords

The first of six training sessions aimed at teaching private landlords in the borough the rules and responsibilities when it comes to renting properties, has been held at Barking Town Hall.

About 20 landlords attended the one-day event, which took place on Tuesday 24 January, to hear about everything from legal expectations and how to set up a tenancy, to repair and maintenance, safety certifications, and the laws around houses in multiple occupations or HMOs.

The course, run by the London Landlords Accreditation Scheme, was launched in 2004 as a way of promoting good practice in the private rented sector across the capital, and is available to any current or prospective private landlord.

Further sessions in are planned for March, May, July, September, and November, although more dates are available across London.

Residents invited to have their say on the 2023/24 council budget proposals

Residents are being encouraged to give their views on <u>Barking and Dagenham</u> Council's 2023/24 budget proposals.

The plans have been announced against a backdrop of severe and sustained cuts to local government, which have seen the council's funding slashed from £103m in 2010 to £80m in 2022. Taking into account inflation of over 40% during this time, funding given to the council is the equivalent of just £57m compared to £103m in 2010.

We are supporting residents through the biggest cost of living crisis in almost half a century and the impact of spiralling inflation has driven up the costs of everyday essentials and is causing a big squeeze on an already stretched budget.

In response to the latest crisis, the council launched a network of community hubs to offer help and advice in neighbourhoods across the borough. We have also partnered with community organisations to create a <u>Cost of Living Alliance</u> to support people as early as possible, including providing help with energy costs, money worries, food and wellbeing.

A number of warm hubs have also been established to support residents who are struggling with their energy bills by providing a warm space for them to go to during the day.

Over the last few years, the council has faced major challenges across all of our services, particularly housing and social care. For every £10 we spend, £7 goes on caring for the most vulnerable people in our community before we can fund anything else and demand on our services continues to rise.

The budget proposals acknowledge that despite making £50million in savings and efficiencies over the last five years, more help is needed from the government if we are to continue to balance the books.

To continue to provide key services for our most vulnerable residents, we are proposing a 5 per cent increase in Council Tax, including 2 per cent ringfenced for social care, which will add around £1.33 per week onto the average band D property (excluding the GLA element) from next April. The cost of delivering the council's services have been affected by inflation which has increased by 10.1% over the past year.

Funding is available to vulnerable residents to support them with essentials over the coming months.

Arts Council funding cuts in capital will harm economy, MPs warn

Both the Conservative and Labour co-chairs of the all-party parliamentary group (APGG) for London have expressed serious concern at Arts Council England (ACE) reducing its funding allocations in the capital by around £50 million, announced in November last year.

Sir Bob Neill MP, Chair of the APGG for London, said: "Hundreds of highly skilled jobs are at risk, all for the sake of rigidly redistributing funding away from London at any cost. I fear these decisions will damage London's world-leading culture sector, which in turn will harm the wider economy and the UK's invaluable soft power. As a cross-party group of London MPs, we urge ministers to intervene."

Florence Eshalomi MP, Co-Chair OF THE APGG for London, said: "As much as we support the aspiration to level up the country, this cannot be achieved by levelling down London. Cutting arts funding for the capital and ending support for these irreplaceable cultural assets is a short-sighted policy that will leave us all poorer."

The <u>APPG for London</u> is a forum for MPs and peers to work together on a cross-party basis to strengthen the capital's voice in parliament. The group's secretariat is provided by London Councils.

Levelling Up Fund

The government has announced funding for more than 100 projects around the country who will receive a share of £2.1 billion from round 2 of the government's Levelling Up Fund.

Get Online London: Device Bank

<u>Get Online London</u> is London's first Digital Inclusion service offering Londoners access to refurbished devices, free mobile connectivity and digital skills they need to get online.

Supported by the London Office of Technology and Innovation (LOTI) and the Mayor of London, the service is delivered by Good Things Foundation.

A core element of the service is a new 'Device Bank' for London with the aim of providing appropriate devices to Londoners who need them. Creating this pool of devices and equipment will heavily rely on donations from private and public sector organisations. There are no costs involved for the organisations wishing to donate devices. This will also support the circular economy, reducing ewaste as well as having a positive social impact.
