Council announces new plans for Women's Museum

Last Wednesday, 8 March, on International Women's Day, the council announced the next steps in the development of a Women's Museum at 4 - 5 Barking Wharf.

Linked to the borough's accredited local history programme at Valence House Museum and Archives - the space will serve as a platform to showcase the history, heritage, stories and role of women from the local area and beyond.

Set to open in late 2023, it will showcase exhibitions, learning opportunities,

events and workshops. The Women's Museum will be a new place for conversation and gathering, and a place to explore issues relevant to the collective and diverse experiences of women.

The museum will build on our work to support the empowerment of women and girls, such as work being led through local organisations like Arc Theatre and Excel Women's Centre, as well as the recently opened We Rise Hub at Barking Learning Centre which provides support, activities and events led by and for survivors of domestic abuse.

Upcoming programme highlights include:

- An inaugural artist commission by designer Claire Mason covering the façade of the future Women's Museum space, installed for Women's Empowerment Month until Autumn 2023.
- An inaugural exhibition focusing on the radical history of the Abbesses of Barking Abbey conceived by curator and artist Nephertiti Schandorf, opening in late 2023.
- A newly commissioned girl's empowerment programme led by Arc Theatre aimed at local young people aged 11 years and older and launching in November 2023.



Borough hosts London Fire Brigade's high rise fire safety exercise

Residents of the Gascoigne estate have been alerted to an ongoing training exercise between the London Fire Brigade (LFB) and the council at Fiske Court in Barking.

The purpose of the exercise is to implement and practise lessons learnt following the Grenfell tragedy. This exercise is to practice the LFB's tactics for keeping residents safe in high-rise buildings in case of a fire.

Fiske Court is a decanted council tower block and will serve as a training facility for a period of approximately 9 months until demolition works commence as part of our estate regeneration programme.

There will be four planned exercises every month until July and the other dates for this month are Monday 27 and Tuesday 28 March.

Residents may see lots of fire engines and cosmetic smoke in the area between these times. If they have a genuine emergency, they should still call the emergency services on 999 as normal.



Thames View Skate Park given new £40,000 lease of life

A local skatepark has been given a £40,000 revamp, funded by one of our partners, Clear Channel and delivered by their sub-contractors JCS. The Council also contributed two new activity boards and plants.

Thames View Skate Park re-opened on Friday 10 March ready to serve the local community.

Working with the council and local residents, Clear Channel's upgrade to Thames View Skate Park has seen new eco-friendly benches made from reclaimed wood and planters fitted at the site, with the area also given a thorough clean and a fresh, vibrant new lick of paint.

The work carried out by Clear Channel is part of their Social Value commitment with funding for the project being awarded to the skate park through a competitive application process in partnership with Barking and Dagenham Giving.

The council's social value policy requires that any organisation working with the council to provide goods or services over a £100,000 threshold must set out in their tender application how they can deliver wider economic, social or environmental benefits for our residents.


We've been sharing lots of ways residents can get help with money, food, energy, wellbeing and more.

Help and support available for residents through the Household Support Scheme

Residents who may be struggling with their finances or to make ends meet are being encouraged to get in touch.

Funding is available to vulnerable residents to support them with essentials over the coming months.

There are also a number of other support services including:

- Our Community Food Clubs which are free of charge and can provide £20 worth of food per week for a period of either three or six months at www.lbbd.gov.uk/community-food-clubs
- Our money and debt webpages provide an income and expenditure calculator and budgeting tools that will help people understand how much money they have coming in and how much is going out, helping them look at areas where they can make savings at www.lbbd.gov.uk/money-and-debt
- Residents who are worried about their finances and need help to tackle debt can now get advice and support from our local Barking and Dagenham Money website at: www.bdmoney.co.uk
- People struggling with increasing energy costs should contact their energy supplier about possible funds they may be entitled to, to help them through difficult periods. They can also access the Warm Homes Grant at www.gov.uk/the-warm-home-discount-scheme
- People with disabilities who aren't claiming specific disability benefits
 may be able to take advantage of a number of benefits available,
 including Personal Independence Payments, Disability Living Allowance
 (for children), and Universal Credit. For those caring for someone with
 disabilities they may be able to claim Carer's Allowance although this is
 means tested, at www.gov.uk/financial-help-disabled/disability-and-sickness-benefits
- People with a water meter who are experiencing financial difficulties may
 want to look into the Watersure scheme at
 www.ofwat.gov.uk/households/customer-assistance. Most water
 companies also have a fund to help those who are struggling, and it
 might be worth contacting their water provider.

- People who are out of work and looking to get into employment can get help and support from our Job Shops at www.lbbd.gov.uk/help-finding-work
- Anyone worried about a lack of skills can find courses and support on the Adult College website at https://adultcollege.lbbd.gov.uk/

Women's Rough Sleeping Census

Last Wednesday (8 March) was International Women's Day and London Councils are proud to have supported the first London-wide Women's Rough Sleeping Census.

Led by the Single Homeless Project, the Women's Development Unit, and St Mungo's, the census is the first of its kind on a pan-London scale and is designed to improve understanding of the extent and nature of women's rough sleeping in the capital.

With a new report on the census due out, boroughs are committed to working with partners across London's homelessness sector to increase safety and

improve outcomes for women sleeping rough.

Michelle Binfield, London Councils' Rough Sleeping Programme Director, said: "Rough sleeping is particularly dangerous for women. The census is a vital tool for helping us understand the scale of the challenge and for targeting resources for successful prevention and frontline support work.

"Boroughs are proud to be part of the pan-London partnership tackling this issue and doing everything we can to help women off the streets and into safe accommodation."

Secondary School Offer Day 2023

Wednesday 1 March was National Secondary School Offer Day 2023, when children due to start secondary school in September found out which school they'd be attending. There were 92,641 applications for secondary school places in London. Of these, 94 per cent were offered a place at one of their preferred schools, figures published by the Pan London Admissions Boards show.

London Councils Executive Member for Children and Young People, Cllr Ian Edwards, said: "It is positive that once again the overwhelming majority of children have an offer from one of their preferred schools. Boroughs have worked diligently with schools to ensure there are sufficient places to meet the high demand for school places across the capital.

"London is an incredibly high-performing region at GCSE level with 90 per cent of schools rated Good or Outstanding by Ofsted, which means local families can be confident that their child will receive an excellent education.

"We remain keen to work with Government to respond to pressures surrounding secondary school places and to support the growing demand for development of specialist SEND provision at a local level, ensuring that all London pupils have the best start in life."

The Future of Local Government Finance and Fiscal Devolution

It is now a decade since the London Finance Commission (LFC) highlighted that London enjoys considerably less financial autonomy than other world cities – pointing out, for example, that just 7 per cent of the tax generated in the capital was retained in the capital, compared with over 50 per cent in New York.

While London and the UK have changed considerably since 2013, both the logic that underpinned the original LFC and the recommendations it put forward are just as valid today, argues Paul Honeyben in a new collection of essays from Localis exploring where local government finance might be in 2030. This key annual public health conference will offer delegates the opportunity to hear from leading experts on the very latest thinking in national public health policy issues, as well as gaining insights from those delivering on the ground. Over three half day virtual sessions, delegates will be able to put their questions and comments to a line-up of speakers and will have the opportunity
