In his video this week, the Leader gives an update on an enforcement case from a few years back, where in 2019, enforcement officers visited Barking Halal Meat & Fish and found some serious health and safety breaches – including selling poor quality chicken to customers which was meant to be pet food.

He also talks about our efforts to lobby for more police resources for the borough, which we desperately need to keep everyone safe and adds that he

has written to the Met Commissioner, to raise urgent concerns and demanding they do much, much better for our borough.

Funding is available to vulnerable residents to support them with essentials over the coming months.

- People with disabilities who aren't claiming specific disability benefits

### Homelessness Jobs Fair

Following the success of last year's inaugural Homelessness Jobs Fair, the event is returning to London this year and on a bigger scale.

Bookings are now open for the 2023 Homelessness Jobs Fair which will take place at Boxpark Wembley on 10 July, with more than 40 employers in attendance.

The Jobs Fair is for anyone looking to make a positive impact on the lives of those experiencing homelessness and a career in tackling homelessness in London, as well as those already in the sector who are looking to progress their career.

The Homelessness Jobs Fair is supported by London Councils, the Department for Work and Pensions, the Mayor of London, Homeless Link and Bloomberg Associates.

### Supporting frontline community charities in London

Charities providing frontline community services in London are meeting increased demand resulting from the pandemic and the cost of living crisis. At the same time, funding for capacity building to support them is limited and patchy, depending on the available funding and capacity of a small number of statutory bodies and trusts to fund it.

Based on in-depth interviews with eight capacity building organisations and five London funders, including London Councils Strategy Director Yolande Burgess, Resources for London, has published a survey of the issues currently facing voluntary sector infrastructure organisations in the capital.

### **London Councils VAWG report launched at Parliament**

London Councils launched its <u>report</u> on the complex and fragmented funding landscape for support services for victims and survivors of Violence against Women and Girls at an event in Parliament.

The event heard reflections on the report's findings from London Council's Executive Member for Community Safety and Violence Against Women and Girls Cllr Jas Athwal, Donna Covey at AVA and Shadow Justice Minister Ellie Reeves MP, who all agreed that the current system doesn't work well enough for victims and survivors.

### **Member Briefing**

The next member briefing will take place on Tuesday 13 June at 7pm. It will be held in Barking Town Hall and will focus on Waste Strategy.

#### Training from Local Government Information Unit (LGiU)

The LGiU are offering the following sessions:

Chairing: Wednesday 7 June, 9.30am to 12.30pm (Online)

Improve how you chair online, hybrid and in-person meetings and learn easy-to-implement techniques to manage participation. Master the technology and

processes around online meetings and gain confidence in how you navigate challenging situations that may arise. The session will also touch on team dynamics and how to best facilitate productive and engaging sessions.

**Scrutiny:** Wednesday 21 June, 9.30am to 11.30am (Online)

Asking questions and actively listening is of course a crucial skill for elected members. But this is most intensely highlighted when it comes to scrutiny, probing, and questioning in a local authority. This engaging training will keep participants on the edge of their seats in anticipation while providing comprehensive tools and frameworks to implement moving forward.

### **Training from Local Government Association (LGA)**

The LGA are offering the following sessions:

Adult social care assurance: the return of regulation and the role of elected members: Tuesday 6 June, 1.30pm to 3pm (Online)

On 1 April 2023, a new system of adult social care assurance went live. Under the Health and Care Act 2022, the Care Quality Commission (CQC) has a new duty to independently review and assess councils' delivery of their adult social care duties under the Care Act, and the Secretary of State for Health and Social Care has new legal powers for statutory intervention in cases where a council is judged to be failing, or has failed, to discharge its duties. A programme of improvement and support will also be part of the assurance process.

The role of elected Members in assurance is important, as is the role of democratic leadership in maximising the opportunities of assurance and mitigating its risks. This webinar – specifically aimed at elected Members – will bring together senior colleagues from the Department of Health and Social Care, the regulator and local government. Delegates will hear updates on all recent developments and have plenty of opportunity to raise questions and comments with all speakers.

**Investment cost transparency:** Wednesday 21 June, 10am to 1pm

This session will provide:

- An explanation of the purpose and background of the Board's groundbreaking Code of Transparency.
- A case study from an LGPS fund on how investment cost information has been used
- A troubleshooting session on how to use the online reporting system, run in conjunction with Byhiras (the system providers), and
- A facilitated discussion on the information that fund officers should be receiving and how this information should be reported to pension boards and committees.

### **One to One Development Sessions**

The LGA are offering councillors the opportunity to have one-to-one development conversations with one of the Leadership Academy Facilitators. This will be available to councillors in leadership positions for the next three months. These sessions are not political and will be provided by tutors from the LGA's Leadership Academy programme who a number of councillors might have met from participation on the programmes. They will be focussed on helping councillors adapt their personal leadership style through three structured coaching calls.
