Leader's borough update

In his video this week, the Leader mentioned last Wednesday night's Storm Ciaran which was followed by heavy rains and wind but reassured residents that our crews are working hard to remove flood water and keep people safe.

He also mentioned his visit to the newly developed Gascoigne Estate to celebrate the completion of more affordable and environmentally friendly homes - part of the new neighbourhood which will see 2,000 homes built.

The Leader also provided a reminder of the EFG Jazz Festival - a fantastic

programme of free entertainment and events taking place between the 10-19 November.



Low carbon, affordable homes completed in Gascoigne Neighbourhood

The borough's greenest housing block has been completed by Be First - the eight new properties are affordable and feature cutting edge technology to help its residents reduce their emissions and energy bills.

The homes 'fabric first' approach means the materials used ensure it is airtight and thermally and energy efficient. The homes are also ready for low carbon technologies like heat pumps and networks.

Triple glazed windows and improved ventilation provide high levels of insulation, protection from noise pollution, and prevent damp and mould developing while maintaining a comfortable, warm indoor temperature.

Homes across the whole of the redeveloped Gascoigne Neighbourhood are connected to a district heating system and have been designed with energy efficiency in mind, ultimately providing a 40% CO2 emissions reduction against building regulations. On top of this, all phases of the Gascoigne Neighbourhood are adopting an active travel development strategy, meaning pedestrians and cyclists are prioritised which promotes sustainable travel and enhances a sense of community.



Residents invited to have their say on changes to the Council Tax Support Scheme

Residents are being invited to have their say on proposed changes to our working age Council Tax Support Scheme. The proposed changes include the introduction of income bands, making it easier for residents to identify the discounts they are eligible for.

The proposals may result in changes to some of the amounts people receive. Any potential changes would take effect from 1 April 2024.



They will also be able to gain a Level 1 Health and Safety in Construction qualification.

On successful completion of the course, participants will gain the green CSCS labourer card which will allow them to work safely in the construction industry. Staff at the BRIC will also assist participants in gaining other industry related construction cards.

Funding is available to vulnerable residents to support them with essentials over the coming months.

 may be able to take advantage of a number of benefits available,

- companies also have a fund to help those who are struggling, and it might be worth contacting their water provider.

Local Government News

Increase in housing pressures puts council budgets under strain

With reports that the national housing crisis is putting increasing pressure on councils' budgets across the country, London Councils is reiterating calls for the government to work with councils to reverse the number of households relying on temporary accommodation.

The number of households entitled to homelessness support from a London borough increased 15.2% between April 2022 and April 2023. London Councils is urging the government to take the following steps:

Raise Local Housing Allowance (LHA). LHA, which eligible households receive as part of their housing benefit or Universal Credit if they have a private landlord, has been frozen since 2020 despite private rents increasing since then. Boroughs believe LHA should be increased to cover at least 30% of local market rents – a policy the government adopted successfully at the height of the Covid-19 pandemic.

Support councils to buy accommodation sold by private landlords. 40% of all homes listed for sale in London in 2022 were previously let by a private landlord. The government should build on initiatives such as the Local Authority Housing Fund by providing increased capital investment for housing acquisitions, particularly to acquire homes being sold by private landlords as they exit the market.

Boost Homelessness Prevention Grant funding. Local authorities play a vital role in supporting struggling households to avoid homelessness. Councils require an immediate emergency funding increase to ensure local services have the resources needed in the face of rising levels of demand for support.

Increase Discretionary Housing Payments. These payments are used by councils to help residents in financial crisis meet their housing costs. They are an essential homelessness prevention tool, but government funding for Discretionary Housing Payments in 2023-24 has been frozen at 2022-23 levels, despite significantly increasing homelessness pressures.

Bring forward a cross-departmental strategy to reduce homelessness.

Tackling homelessness must become a major priority at a national level with government departments working together – in addition to key partners such as local authorities – as effectively as possible.

Eco-refill project is putting the circular economy in schools

Pupils in Richmond and Wandsworth are being encouraged to change behaviours around plastic consumption and develop entrepreneurial skills through eco-refill shops located in their schools.

The project, currently being piloted in 11 schools across the two boroughs, is explained in this <u>blog</u>, <u>by Ali Malvern</u>, <u>Programme & Policy Lead</u>, <u>Climate</u>

<u>Change and Sustainability</u>, <u>for Richmond and Wandsworth Councils</u>, who says: "the model for these eco-refill shops is a great example of affordable circular economy in the local area while working to draw in the wider community."
